- 5. The Applicant shall choose an Employment Mentor from the PAC approved list of Registered Architects with more than 10 years of experience for his/her internship.
- 6. The Applicant fill in the Trainee Architect's Logbook which the latter shall need to use to keep record of activities undertaken during the internship period.
- 7. The Applicant must submit the Employment Mentor's Testimonial to the PAC on as prescribed in the logbook, and any other relevant documents as may be requested by the council.
- 8. In case the Applicant had done or wishes to do his/her professional experience and development abroad, he/she will be requested to furnish registration details of his/her Employment Mentor(s). The PAC reserves the right to approve or reject any such Employment Mentor which does not satisfy the requirements as may be prescribed by the council.
- 9. Only complete application forms and required documents shall be forwarded to the council for recommendation.
- 10. The Applicant shall effect payment of fees as may be prescribed at the moment of the application and upon approval of same.
- 11. The Registrar shall enroll the applicant as "Trainee Architect" upon approval of the Council.
